- C. Academic governance participation survey for academic specialists (Nicolas Gisholt)
 - In May of 22 the percentage of Specialists that was part of Academic Governance was 5% in relation to Faculty members (Tenure; Professor; Associate Professor; Fixed Term)
 - 2. Survey had 111 responses of 900+ total Academic Specialists
 - 3. Questions covered present and past engagement both of them showed higher than 95% of Specialists hadn't been part of a university committee and were not current members or currently running for a university committee.
 - 4. On the last question: If a Specialist seat were created for every university committee, would you consider running, 62% responded that they would "seriously consider" or "would be more likely to consider" running.
 - 5. Implications: in the next election cycle, it is highly probable that enough Specialists would be willing to participate to fill the new Specialist seats of committees; would add diversity to Academic Governance and meet some of the missions of the University and DEI Strategic Plan
 - 6. Next steps: present the results to Secretary of Academic Governance Tyler Silvestri
 - 7. Aaron Reifler commented: This would be a great topic for the elections sub-committee.
