- V. Associate Provost & Associate Vice President for Faculty and Academic Staff Affairs Report (Ann Austin and Kathy Charles)
 - A. Ann's comments: Unsettling/challenging fall on campus in different ways, specifically interactions between Board of Trustees and President. Grateful for President Stanley's office. Provost Teresa Woodruff will be stepping in to Interim President role within the week; viewed as a very positive move.

- Fundamentals of University remain strong. Appreciates day-to-day efforts of the MSU community.
- B. Questions for Ann: How will MSU President appointed roles be effected by transition to Interim President (Aaron Reifler)? Once the Interim President assumes the role she will move forward with these appointments. Interim Provost will be top priority, no other dramatic changes expected. A search will be underway for new president; Provost Woodruff could apply.
- C. Recent holiday announcements (Kathy Charles)
 - i. Time between Christmas and New Year's (Dec. 23- Jan.
 - ii. MLK Day Observance off for all University employees
 - iii. Seeking input on additional days. There will be opportunities for this committee to provide input and considerations on "floating" holidays.

 - Modifications to Form for Progress and Excellence, DEI included on this updated form as an optional section in preparation for changed coming throughout the University.
 - ii. Earlier this year, Provost Woodruff shared that DEI will be incorporated into Promotion & Tenure processes. Review process in 2022-2023. Encouraging current candidates to include DEI efforts in their summaries.
 - iii. Guidance/instructional memo (instructional) coming out in November for Academic Specialists, as well as fixed-term and tenure-track faculty, on how to incorporate DEI into documents.  - ii. Unions- MEA (NEA) is reaching out to members. **ASAC is not endorsing or getting involved, but need to be aware.** Individual members should seek information for themselves. Comment that if 50% or more people sign up then there will be no vote and unionization could automatically occur. Due date to sign up in spring.
 - iii. Teams message from Tyler Sylvester from Academic Governance. Met with Ashley and Aaron. Tyler drafted the letter and there were a number of organizations also supporting. Other candidates were in mind and there was concern and desire to support this T. Woodruff. Letter went to board of trustees. There were enough votes. ASAC would have been the only committee not included. Would appreciate vote to be anonymous (Nicholas). Process needs to be considered in future. Perhaps the bylaws committee could address this. Should chair have authority in last minute decisions? Should all voting be anonymous? As a rep, less anonymous for supporting action. In election, anonymous.

- C. Promotion & Compensation (Karen Kangas-Preston & Jenn Petzko)- Reached out to discuss ongoing need for new sample promotion materials. Working with Kathy to identify those people to approach. Drafting FAQ document to address handbook updates. We want to know results of survey that went out. When will these changes be implemented? Great idea people, but not everything can be implemented from subcommittee. Need support from Academic HR and other support. People are choosing to leave MSU because of difficulties that have been mentioned, showing progress moving forward will help. Kathy will meet with subcommittee, hopefully 2 weeks from now at a midpoint. Subcommittee planning on meeting regardless if Kathy can make it.
- D. Bylaws (Karen Kangas-Preston) See if other groups address quick turnaround decisions, how should this be addressed? Maybe incorporate some voting language.
- E. DEI (Grace Pregent & Ashley Maloff)
 - i. Interest in planning an event in the spring, maybe with MLK day or other spring time. Perhaps we could join in an event already going on. Meeting for dinner in one of the residence halls is another idea. DEI + social event (local business, e.g. dinner).
 - ii. DEI bylaws language changes/suggestions need to be discussed when more committee members are present.
 - a) Proposed language: "Informed by an intersectional framework, the DEI Subcommittee collaborates and consults with ASAC and university partners to advocate for and work

- together towards diverse, inclusive, equitable, and accessible spaces for the MSU specialist community."
